On July 18, 2013, the Commission issued an Order of Notice in the above-captioned matter scheduling a prehearing conference for September 19, 2013. The Office of Consumer Advocate (OCA) filed a letter on July 3, 2013 indicating its participation in this docket pursuant to RSA 363:28.

The prehearing conference was held as scheduled and attended by Public Service Company of New Hampshire (PSNH), Staff and the OCA. No other parties filed a motion to intervene or appeared at the prehearing conference. Following the prehearing conference, PSNH, Staff and the OCA met in technical session to develop a procedural schedule for the filing. The agreed-upon procedural schedule is as follows:

Staff respectfully requests that the Commission approve the proposed procedural schedule. At the time of the technical session, PSNH did not anticipate a need to file rebuttal testimony; however, the procedural schedule provides sufficient time for the Company to file rebuttal testimony, if necessary. Staff will inform the Commission if there are any changes to the procedural schedule.
