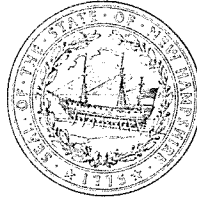

On June, 26, 2013, TFS Energy Solutions, LLC d/b/a Tradition Energy (Tradition) filed an application with the Commission to register as a provider of natural gas aggregation service. On July 1, 2013, Tradition submitted a revision to the information initially filed in its application. Staff reviewed the information, as revised, and determined that the application is complete.

The Commission approves your application to register as a provider of natural gas aggregation service, effective July 8, 2013. The registration is for a term of 2 years and expires at the end of business on July 7, 2015. Pursuant to N.H. Code Admin. Rules Puc 3003.02(a), you must submit your next renewal application at least 60 days prior to the expiration of the registration approved here, on or before May 8, 2015.

Please be aware that registered providers of natural gas aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at: <http://www.puc.nh.gov/Regulatory/Rules/PUC3000.pdf>.
