On July 2, 2013, PurePath Energy, LLC filed an application with the Commission to register as a provider of electric aggregation service. Staff reviewed the information in the filing and determined that the application is complete.

The Commission approves your application to register as a provider of electric aggregation service, effective July 24, 2013. The registration is for a term of 2 years and expires at the end of business on July 23, 2015. Pursuant to N.H. Code Admin. Rule Puc 2003.05(a), you must submit your next renewal application at least 60 days prior to the expiration of the registration approved here, on or before May 24, 2015.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Code Admin.
