Re: DW 13-217 Eastman Sewer Company, Inc.
Petition for Authority to Use Capital Funds

To the Parties:

On July 25, 2013, the Commission received a request from Eastman Sewer Company, Inc. (Eastman) for authorization to use \$16,132.28 from its capital reserve fund to pay capital expenses related to Eastman's evaluation of alternatives to its current method of discharging treated effluent. Eastman filed a second request on August 16, 2013, for authority to use an additional \$6,000 from its capital reserve fund to install data logging capability in its lagoon pump station.

On August 27, 2013, Commission Staff filed a recommendation that Eastman be permitted to withdraw monies from its Capital Reserve Fund for the proposed uses. Staff concluded that the proposed uses of the Capital Reserve Funds are appropriate and consistent with Commission Order No. 20,390.

Accordingly, the Commission has determined that Eastman's request to withdraw \$16,132.28 and \$6,000 is approved.
