

Dear Mr. Leibman:

The Commission has been made aware that REP Energy, LLC (REP Energy) has been suspended from participation in the New England electric wholesale markets, effective today, December 16, 2014. As directed by ISO New England, the New Hampshire electric distribution companies are currently in the process of moving customers from REP Energy back to default service with each customer's local electric distribution utility.

To ensure that REP Energy remains registered as a competitive electric power supplier in New Hampshire, please provide the following information as soon as possible:

1. Evidence of authority to obtain electric supply in the New England Wholesale Power markets; and
2. Confirmation that REP Energy's regional wholesale market suspension does not affect the status of the irrevocable standby letter of credit issued by Comerica Bank for the benefit of the Commission.

REP Energy shall not solicit or enroll any new retail customers until such time as the Commission has received adequate responses to the above requests and notified REP Energy that it may resume enrolling new customers. Further, those customers returned to utility default service as a result of REP Energy's regional wholesale market suspension shall not be automatically re-enrolled with REP Energy. Those customers must affirmatively choose REP Energy as their energy supplier in accordance with the Commission's rules.
