

Competitive Electric Power Supplier Status

Dear Mr. Leibman:

The Commission is in receipt of your letter on behalf of REP Energy, LLC (REP Energy) dated December 26, 2014, and received on December 29, 2014, in response to the Commission's secretarial letter dated December 16, 2014.

We read your letter to confirm that REP Energy has met the necessary requirements to lift its suspension and resume its active participation in the regional wholesale electricity markets administered by ISO New England, Inc. (ISO-NE), and we have independently confirmed REP Energy's reinstatement through communications with an ISO-NE representative. To ensure a complete paper record, REP Energy is hereby directed to submit a copy of the written notice from ISO-NE that REP Energy cured its obligations and its market participant suspension has ended, as requested in the Commission's December 16, 2014 secretarial letter.

Your letter also confirms that the irrevocable standby letter of credit provided to the Commission for the account of REP Energy has not been compromised and remains in full force and effect.

Based on these confirmations, REP Energy is hereby authorized to resume solicitation and enrollment of new customers in New Hampshire, effective as of the date of this letter. Note that REP Energy was not authorized to solicit or enroll new customers during the period from December 16, 2014 through January 1, 2015, pursuant to the Commission's secretarial letter dated December 16, 2014.

The Commission is aware that, despite this prohibition, REP Energy has submitted a number of enrollments to the New Hampshire electric distribution companies. Pursuant to the Commission's December 16, 2014 secretarial letter, those enrollments are not valid enrollments, and all enrollments submitted prior to the date of this letter will be rejected by the New Hampshire electric distribution companies. Affirmative customer consent to select or accept

REP Energy as the provider of electric energy service must have been given no earlier than January 2, 2015 to be deemed valid.

In addition, the December 16, 2014 secretarial letter stated that those customers returned to utility default service as a result of REP Energy's regional wholesale market suspension "shall not be automatically re-enrolled with REP Energy;" instead, these customers "must affirmatively choose REP Energy as their energy supplier in accordance with the Commission's rules." Each such customer's affirmative selection of REP Energy must have occurred after January 1, 2015.

These restrictions are based on RSA 374:28-a, which prohibits "slamming," and N.H. Code Admin. Rules Puc 2004.05, regarding transfers of service by competitive electric power suppliers. Please note that, pursuant to Puc 2005.01(b), the Commission may initiate an adjudicative proceeding to impose penalty sanctions of up to \$1,000 per day for each violation of any of the provisions of Puc 2004 or any applicable state statute or Commission order.
