

On August 14, 2013, Capital Energy, Inc. filed an application with the Commission to register as a provider of electric aggregation service. Staff reviewed the application and determined that it is complete.

The Commission approves your application to register as a provider of electric aggregation service, effective August 26, 2013. The registration is for a term of 2 years and expires at the end of business on August 25, 2015. Pursuant to N.H. Code Admin. Rule Puc 2003.05(a), you must submit your next renewal application at least 60 days prior to the expiration of the registration approved here, on or before June 26, 2015.
