On August 19, 2013, Cady Electric, LLC (Cady Electric) submitted an application seeking certification for Jeremiah Cady to serve as an independent monitor for owners of customer-sited sources in New Hampshire that qualify for New Hampshire renewable energy certificates (RECs), pursuant to N. H. Code of Administrative Rules Puc 2505.09. As an independent monitor, you would provide monitoring services for New Hampshire-based, customer-sited sources qualifying for renewable energy certificates (RECs).

Staff has reviewed the application and believes it meets the requirements for certification inasmuch as you are currently licensed as a master electrician by the State of New Hampshire. Based on Staff's recommendation, the Commission has determined that your application meets the requirements for certification pursuant to New Hampshire Code of Administrative Rules, Puc 2505.09.

Additionally, please bear in mind that all independent monitors in the State of New Hampshire are subject to specific requirements spelled out in Puc 2505.09(h), (i), and (j).
