To the Parties:

On September 20, 2013, a duly noticed prehearing conference was held in the above referenced proceeding. Appearances at the prehearing conference were entered by representatives of Unitil Energy Systems, Inc., Liberty Utilities, North American Power and Gas, LLC, New Hampshire Electric Cooperative, Inc., Electricity NH, Retail Energy Supply Association, PNE Energy, Public Service Company of New Hampshire, the Office of Consumer Advocate, and Commission Staff. Interventions were granted to Electricity NH, Retail Energy Supply Association, PNE Energy and North American Power and Gas, LLC.

Following the prehearing conference, the parties and Staff met in a technical session and agreed upon the following schedule which was submitted to the Commission by letter from Staff dated September 24, 2013:
