

Dear Mr. Behrmann:

On August 26, 2013, the Commission received an application on behalf of Stephen Maddock (Maddock) from Revolution Energy Aggregation, LLC (Revolution Energy Aggregation), requesting Commission approval for Class II New Hampshire REC eligibility for the Maddock photovoltaic (PV) array pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. Certification of this facility will enable Revolution Energy Aggregation to add this facility to its aggregation pursuant to Puc 2506.01.<sup>2</sup>

Staff has reviewed the Maddock application and has recommended approval of the applicant's PV array as eligible to be aggregated by Revolution Energy Aggregation for Class II RECs effective August 26, 2013, the date Staff was able to determine that the application was complete.

Since this facility is a customer-sited source, its output is not recorded in the ISO New England Market Settlement System and, as a result must be monitored and verified by an independent monitor. The application states that Paul Button, Energy Audits Unlimited, will monitor the facility's output pursuant to N.H. Code of Administrative Rules Puc 2505.08 and 2505.09. Mr. Button will report this facility's total output

annually to the customer, the Commission and the NEPOOL Generation Information System as part of Revolution Energy Aggregation's Class II aggregation pursuant to Puc 2505.09(h)(3). The GIS facility code assigned to Revolution Energy Aggregation is NON 15299.
