On April 4, 2014, Staff filed a letter requesting on behalf of Staff and the parties that the April 11, 2014 technical session be cancelled and that the procedural schedule in this docket be suspended until Senate Bill 324 has completed the legislative process. Staff's letter indicated that, once the outcome of Senate Bill 324 is known, Staff will work with the parties to determine how best to move forward with this docket and report back to the Commission.
