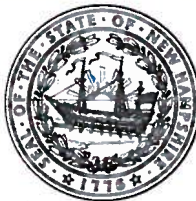

On September 23, 2014, Northern New England Telephone Operations LLC and Enhanced Communications of Northern New England, Inc.
