**TRANSFER  
AUTHORIZATION FOR RENEWABLE ENERGY CERTIFICATE  
(REC) ELIGIBILITY**

On June 15, 2015, the Commission received a request from Knollwood Energy of MA (Knollwood) to transfer the Class II RECs attributable the **George Rickley** photovoltaic (PV) array to the Knollwood aggregation. The facility was originally approved for REC eligibility and participation in the Solar Farm Bank aggregation on February 21, 2013. Knollwood's request, on behalf of the facility owner, indicates that participation in the Knollwood aggregation will begin with July 1, 2015 production. Based on Staff's recommendation, the Commission hereby approves inclusion of the facility in the Knollwood aggregation effective as of July 1, 2015. The Commission also issues this certificate of eligibility to reflect the facility's new GIS Facility Code NON49767.
