On September 18, 2013, Gulf Stream Energy Consultants, LLC filed an application with the Commission to register as a provider of electric aggregation service. Staff reviewed the application and determined that it is complete.

The registration is for a term of 2 years and expires at the end of business on September 19, 2015. Pursuant to N.H. Code Admin.
