On September 24, 2013, Groom Energy Solutions, LLC submitted an application with the Commission to register as a provider of electric aggregation service. Staff reviewed the application and determined that it is complete.

The Commission approves your application to register as a provider of electric aggregation service, effective October 23, 2013. The registration is for a term of 2 years and expires at the end of business on October 22, 2015. Pursuant to N.H. Code Admin. Rule Puc 2003.05(a), you must submit your next renewal application at least 60 days prior to the expiration of the registration approved here, on or before August 23, 2015.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 2000 – Competitive Electric Power Supplier and Aggregator Rules. These rules are available at: <http://www.puc.nh.gov/Regulatory/Rules/PUC2000.pdf>. Please also be aware that the Commission has opened Docket DRM 13-151 to consider revisions to these rules. The revised rules may contain different requirements for maintaining registration as a provider of electric aggregation service that might affect your registration.
