On October 29, 2014, Ambit Northeast, LLC d/b/a Ambit Energy (Ambit), a competitive electric power supplier currently authorized to provide service in the franchise area of Public Service Company of New Hampshire filed a request to expand its service area to include the franchise areas of Liberty Utilities (Liberty) and Unitol Energy Systems (UES). With its filing, Ambit included copies of certificates demonstrating it had completed electronic data interchange (EDI) testing with Liberty and UES.

Staff reviewed the filing and recommended the Commission approve the request, in a memorandum filed on October 29, 2014. The Commission has reviewed Ambit's filing and Staff's recommendation, and has approved Ambit's request. Accordingly, Ambit is authorized to expand its service area to include the franchise areas of Liberty and UES, effective as of the date of this letter.
