Dear Mr. Behrmann:

On January 10, 2014, the Commission received an application from the City of Berlin Water Works (Berlin Water Works) requesting Commission approval for Class II New Hampshire Renewable Energy Certificate (REC) eligibility for the facility's photovoltaic array pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. On January 13, 2014 an application for Class II REC eligibility was received from Thomas Meredith (Meredith), and on January 16, 2014 an application for Class II REC eligibility was received from Filtrine Manufacturing Company, Inc. (Filtrine Manufacturing). On January 10, 2014 the Commission received a letter from Revolution Energy Aggregation (REA)<sup>1</sup> confirming that Berlin Water Works intended to participate as part of REA's aggregation of Class II eligible facilities. A letter confirming both the Meredith and Filtrine Manufacturing facilities' intention to participate as part of REA's Class II aggregation was received January 23, 2014.

The Commission, in a non-adjudicative process, is required to issue a determination of whether a facility meets a particular classification within 45 days of receipt of a completed application. The above-named facilities are customer-sited sources and meet the Class II eligibility requirements under RSA 362-F:4, II. Based on review of the applications Staff recommends that the Commission approve the Berlin Water Works PV array as part of the REA's Class II aggregation effective January 10, 2014, and the Meredith and Filtrine Manufacturing PV arrays as part of REA's Class II aggregation effective January 23, 2014, the dates the Commission received the information needed to complete the applications.


Since these facilities are customer-sited sources, their output is not recorded in the ISO New England Market Settlement System and, as a result must be monitored and verified by an independent monitor. Paul Button, Energy Audits Unlimited, will monitor the Berlin Water Works and Meredith facilities' output pursuant to N.H. Code of Administrative Rules Puc 2505.08 and 2505.09. Mr. Thomas Kelly will monitor the output from Filtrine Manufacturing. The independent monitors will report these facilities' total output quarterly to the NEPOOL Generation Information System as part of REA's Class II aggregation pursuant to Puc 2505.09(h)(3). The GIS facility code assigned to REA is NON 15299.

The details for these facilities are listed in the following table:

The Commission has determined that the above-named applicants and REA have provided all the information necessary to demonstrate these facilities' eligibility for REC certification. 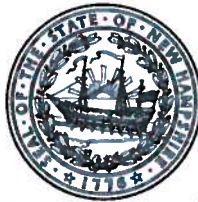

Please be advised that, pursuant to RSA 362-F, the New Hampshire Public Utilities Commission has certified the City of Berlin Water Works (Berlin Water Works), Thomas Meredith (Meredith), and Filtrine Manufacturing Company, Inc. (Filtrine Manufacturing) photovoltaic (PV) facilities as part of the Revolution Energy Aggregation (REA).

Accordingly, REA is eligible to be issued Class II RECs, effective as of January 10, 2014, for the Berlin Water Works array and January 23, 2014 for the Meredith and Filtrine Manufacturing PV arrays. The following table summarizes these new additions to REA, including the New Hampshire Certification Codes. The GIS facility code assigned to Revolution Energy Aggregation is NON 15299.
