To the Parties:

On January 22, 2014, New England Power Company d/b/a National Grid (NEP) filed its report on the reconciliation of its Contract Termination Charges (CTC) billed to Granite State Electric Company d/b/a Liberty Utilities (Liberty) for the period October 1, 2012 through September 30, 2013. The Commission conditionally approved Liberty's Stranded Cost Charge of 0.080 cents/kWh in DE 13-327, Order No. 25,611 (December 23, 2013) subject to Staff's recommendation on the final CTC calculation. On January 29, 2014, Staff filed a memorandum indicating that the documentation provided by NEP supports the proposed 0.080 cents per kWh stranded cost charge for 2014 and that no adjustments are required.

Inasmuch as no further action on the part of the Commission is required, Docket No. DE 14-019 has been closed.
