Dear Mr. Behrmann:

On January 24, 2014, the Commission received a letter from Revolution Energy Aggregation, LLC (REA) requesting Class II New Hampshire Renewable Energy Certificate (REC) eligibility for the Douglas E. Mayer (Mayer) PV facility to participate in the REA aggregation. An application for Class II REC eligibility was received from Mayer on January 29, 2014.

On January 30, 2014 an application for Class II REC eligibility was received from Northern Design Precast, Inc. (Northern Design). A letter from REA requesting that Northern Design be added to the REA aggregation was received February 10, 2014.

The Commission, in a non-adjudicative process, is required to issue a determination of whether a facility meets a particular classification within 45 days of receipt of a completed application. The above-named facilities are customer-sited sources and meet the Class II eligibility requirements under RSA 362-F:4, II. Based on review of the applications Staff recommends that the Commission approve the Mayer PV array as part of the REA's Class II aggregation effective January 29, 2014, and the Northern Design array as part of REA's Class II aggregation effective February 10, 2014, the dates the Commission received the information needed to complete the applications.

Since these facilities are customer-sited sources, their output is not recorded in the ISO New England Market Settlement System and, as a result must be monitored and


verified by an independent monitor. Paul Button, Energy Audits Unlimited, will serve as the independent monitor for both the Mayer and Northern Design facilities pursuant to N.H. Code of Administrative Rules Puc 2505.08 and 2505.09. Mr. Button will report these facilities' total output quarterly to the NEPOOL Generation Information System as part of REA's Class II aggregation pursuant to Puc 2505.09(h)(3). The GIS facility code assigned to REA is NON 15299.

The details for these facilities are listed in the following table:

Please be advised that, pursuant to RSA 362-F, the New Hampshire Public Utilities Commission has certified the Douglas E. Mayer (Mayer), and Northern Design Precast, Inc. (Northern Design) photovoltaic (PV) facilities as part of the Revolution Energy Aggregation (REA).

Accordingly, REA is eligible to be issued Class II RECs, effective as of January 29, 2014, for the Mayer array and February 10, 2014 for the northern Design PV array. The following table summarizes these new additions to REA, including the New Hampshire Certification Codes. The GIS facility code assigned to Revolution Energy Aggregation is NON 15299.
