Request for Partial Waiver of Puc 400 Rules

Dear Ms. Mullholand:

On January 27, 2014, the CLEC Association of Northern New England (CANNE) filed a petition requesting waivers of certain reporting requirements applicable to Competitive Local Exchange Carriers and Competitive Toll Providers under the Puc 400 rules in effect at the time of the filing. Subsequently, on March 11, 2014, the Commission voted to adopt final amendments to the Puc 400 Rules, and the amended rules became effective on March 12, 2014. By secretarial letter dated March 11, 2014, the Commission also waived the deadline for 2014 annual filings under the Puc 400 rules, and extended the due date for such annual filings to April 30, 2014.

In light of the Commission's adoption of the new Puc 400 rules and its extension of the deadline for annual filings due in 2014, the Commission has determined that CANNE's request for waivers is moot. If CANNE or any of its members believes that additional waivers are required, please inform the Commission within two weeks of the date of this letter. If no such further information is received by this date, then this docket will be closed without prejudice.
