Dear Ms. Molinaro:

On February 27, 2014, the Commission received an application filed by Knollwood Energy of MA, LLC¹ (Knollwood Energy) on behalf of Plowshare Farm, Inc. (Plowshare Farm) requesting Class II New Hampshire Renewable Energy Certificate (REC) eligibility for Plowshare Farm's photovoltaic (PV) array pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law.² Certification of the Plowshare Farm PV array will enable Knollwood Energy to add this facility to its aggregation pursuant to Puc 2506.01.

The above-named facility is a customer-sited source and meets the Class II eligibility requirements under RSA 362-F:4, II. Based on review of the application Staff has recommended Commission approval for Plowshare Farm as an eligible Class II facility to be included in the Knollwood Energy aggregation, effective as of February 27, 2014.

Because this facility is a customer-sited source, its output is not recorded in the ISO New England Market Settlement System and, as a result, must be monitored and verified by an independent monitor. The application states that Paul Button of Energy Audits Unlimited will monitor the output of this facility and will report the facility's

output quarterly to the NEPOOL Generation Information System (GIS) and annually to the customer and the Commission as part of Knollwood Energy's Class II aggregation pursuant to N.H. Code of Administrative Rules Puc 2505.08 and 2505.09. The GIS facility code for Plowshare Farm is NON 39371.

Details for this facility are listed in the following table.

Please be advised that, pursuant to RSA 362-F, the New Hampshire Public Utilities Commission has certified the Plowshare Farm, Inc. (Plowshare Farm) photovoltaic facility as a Class II REC eligible facility that will be part of the Knollwood Energy of MA, LLC (Knollwood Energy) aggregation.
