Re: DE 14-080, Dan Watts, Application for Certification as a REC Eligible Facility, Knollwood Energy of MA, LLC Aggregation, Letter of Deficiency

Dear Ms. Lakritz:

On March 24, 2014, the Commission received an application from Knollwood Energy of MA (Knollwood Energy) for Dan Watts, 530 Newmarket Road, Warner, NH. Upon Commission approval the Watts facility would be eligible to receive renewable energy certificates (RECs) and would be included in the Knollwood Energy aggregation.

Review of the application has revealed a discrepancy that will need to be corrected to allow for this facility to be included in the Knollwood Energy aggregation. The current interconnection agreement indicates a nameplate rating of 5.1 kilowatts (kW). The application lists the nameplate capacity as 6.15 kW, and the inverter rating is 6.0 kW. Further review indicates that the Watts residence has either replaced or expanded their system, but they haven't included an updated interconnection agreement.

The Commission will need to receive an updated interconnection agreement to certify the Watts facility as eligible to generate RECs and participate in the Knollwood Energy aggregation.
