On April 21, 2014, Summerview Energy, LLC (Summerview) submitted an application with the Commission to renew its registration as a provider of electric aggregation service. Staff reviewed the application and determined that it is complete. Staff noted that the application was not filed within 60 days of the currently expiring registration as required by N.H. Admin Code Puc 2003.05(a). Staff recommended that the Commission approve the application as a renewal, rather than consider it a new application, because this is the first time Summerview has been tardy with its filing.

The Commission approves your application to renew your registration as a provider of electric aggregation service, effective March 26, 2014. The registration is for a term of 5 years and expires at the end of business on March 25, 2019. Pursuant to N.H. Code Admin. Rule Puc 2003.05(a), you must submit your next renewal application at least 60 days prior to the expiration of the registration approved here, on or before January 25, 2019.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 2000 – Competitive Electric Power Supplier and Aggregator Rules. These rules are available at: http://www.puc.nh.gov/Regulatory/Rules/PUC2000.pdf. Please also be aware that the
