Dear Ms. Howland:

Pursuant to the December 23, 2014 procedural schedule in the above-captioned docket, Staff, Office of Consumer Advocate (OCA) and intervenor testimony is due to be filed today, February 24, 2015.

As you know, the OCA filed a motion on February 23, 2015, to continue the procedural schedule and allow testimony to be filed on March 10, 2015, with all subsequent dates extended by two weeks. Staff did not object to the motion.

Because we must wait for a Commission ruling on that motion, Staff respectfully requests that the Commission allow Staff and OCA testimony to be filed on March 10, 2015. Staff has contacted Conservation Law Foundation (the only intervenor in this docket) which supports the OCA motion.

Staff also contacted Public Service Company of New Hampshire (PSNH). PSNH does not object to the OCA motion or Staff's request; however, PSNH reminded Staff that its next reconciliation filing is due May 1, 2015 and that, shortly thereafter, the company will be filing a petition to adjust the energy service and stranded cost recovery charge effective July 1, 2015. To accommodate the work associated with these filings, PSNH requests that the hearing in this docket be delayed until such time as those filings have been made.
