Re: DT 14-143, Dunbarton Telephone Company, Inc. Revisions to Intrastate Access Tariff

Dear Mr. Nelson:

On May 23, 2014, Dunbarton Telephone Company Inc. (Dunbarton) submitted a filing to revise its intrastate access tariff for effect on July 1, 2014. Other Incumbent Local Exchange Carriers (ILECs) in the state have since filed access rate revisions to their own tariffs.

Staff has requested a 30 day extension to allow sufficient time to review these tariff revisions as a group, to determine whether each filing is compliant with recent Federal Communications Commission (FCC) orders and rules regarding intrastate access rates.

Pursuant to RSA 378:6, IV, "The Commission may, in its discretion and with reasonable explanation, including an explanation of the likely areas of disagreement with the tariff, extend the time for its determination by up to 30 days." In order to allow for an appropriate review of the revised tariff and its compliance with relevant FCC orders and rules, the Commission believes it is reasonable to extend the time for its determination on this proposed tariff revision by 30 days. Accordingly, the period for review of the revised tariff is extended by 30 days until July 18, 2014.
