Bob,

This is a follow-up to the voicemail I left you a few minutes ago.

Your application, which was received by the Commission on July 14, 2014, will be considered an initial application and not a renewal, as your filing was received over 3 months after your electric aggregator registration expired on April 9, 2014, under Docket No. DM 12-045.

In order to complete your application, you will need to submit an additional \$125- check to cover the cost of an initial application. In addition, your filing is missing a copy of the certificate from the N.H. Secretary of State's office stating that you are authorized to do business in New Hampshire. I noted that, for line number 5 of your application regarding this requirement, you state, "Please see attached authorization." There is no attachment.

If you would like to go forward with your application, submit a \$125 check and a copy of the SOS certificate by mail to the address below. Provide 3 copies of the certificate.

Mark,

This is a follow-up to the voicemail you left me today.

To apply for a registration to provide electric aggregation service, go to the Puc 2000 rules (available at <http://puc.nh.gov/Regulatory/rules.htm>). Next, copy Puc 2006.02 from the PDF and paste this into a Word document. Then, address each of the 9 items in Puc 2006.02.

There is a \$250- fee to apply for an initial registration to provide electric aggregation service. Make the check payable to: New Hampshire Public Utilities Commission

In order to complete the registration, you must file paper and electronic versions of the application.

For the paper version, mail an original and 2 copies of the application to:

For the electronic version, email the application to: executive.director@puc.nh.gov.

I noted that your original registration application did not include a copy of a certificate from the New Hampshire Secretary of State (SOS), which shows you are authorized to do business in New Hampshire. In order to renew your

registration, you will need to provide a copy of the certificate. The original certificate, which has a gold-colored seal, is not necessarily something you would have received from the SOS unless you specifically requested it; there is an additional charge for the certificate. If you do not have one, you will have to contact the SOS office to obtain a certificate.
