

Re: Water Service from the City of Somersworth


Dear Property Owners:

As you are aware, the City of Somersworth has been providing your properties with water service for many years. Because it was unable to find any state approval for this service, the city has recently applied to the New Hampshire Public Utilities Commission for after the fact approval.
