Dear Ms. Lakritz:

On July 31, 2014, the Commission received applications filed by Knollwood Energy of MA, LLC¹ (Knollwood Energy) for Shawn Houle (Houle), Greg Sowa (Sowa) and Brian Cook (Cook). Knollwood Energy is requesting Class II New Hampshire Renewable Energy Certificate (REC) eligibility for the Houle, Sowa, and Cook photovoltaic (PV) arrays² and inclusion in the Knollwood Energy aggregation.

The above-named facilities are customer-sited sources and all meet the Class II eligibility requirements under RSA 362-F:4, II. Based on review of the applications, Staff recommends that the Commission certify the Houle, Sowa, and Cook PV arrays as eligible facilities for Class II RECs and inclusion in the Knollwood aggregation effective as of July 31, 2014.

Since these facilities are customer-sited sources, the output is not recorded in the ISO New England Market Settlement System and, as a result must be monitored and verified by an independent monitor. The application lists Paul Button of Energy Audits Unlimited as the independent monitor. The independent monitor's responsibility is to verify the facility's output pursuant to N.H. Code of Administrative Rules Puc 2505.08 and 2505.09. Mr. Button will report the facilities' total output quarterly to the customer and to the NEPOOL Generation Information

System and annually to the Commission as part of the Knollwood Energy's Class II aggregation pursuant to Puc 2505.09(h)(3).
