Dear Mr. Rounds:

On August 6, 2014, Standard Power of America, Inc. (Standard Power) submitted an application with the Commission to renew its registration as a provider of natural gas aggregation service. Staff reviewed the application and determined that it is complete.

The Commission has approved the application to renew Standard Power's registration as a provider of natural gas aggregation service, effective as of June 8, 2014. The registration is for a term of five years and expires at the end of business on June 8, 2019. Pursuant to N.H. Code Admin. Rule Puc 3003.05(a), you must submit the next renewal application at least 60 days prior to expiration of the renewal registration period, on or before April 9, 2019.

Please be aware that registered providers of natural gas aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at: <http://www.puc.nh.gov/Regulatory/Rules/PUC3000.pdf>.

Please note that, effective as of July 1, 2014, each registered natural gas aggregator is subject to an annual assessment of \$2,000, unless it demonstrates that its gross revenue in New Hampshire during the preceding fiscal year (from July 1 through June 30) was less than \$10,000, pursuant to RSA 363-A:2, III and 5.
