On August 6, 2014, Northland Telephone Company of Maine, Inc., d/b/a FairPoint Communications (Northland), submitted a tariff filing containing revisions to specified pages of its NHPUC Tariff No. 1. These revisions consist of administrative changes and changes to non-recurring charges for Custom Calling features. Staff reviewed the proposed tariff revisions submitted by Northland and, following its investigation, recommended these proposed changes be allowed to go into effect. The Commission has accepted Staff's recommendation that the proposed tariff revisions be allowed to take effect.
