On June 1, 2018, Public Service Company d/b/a Eversource Energy (Eversource) filed a request to extend the June 1st filing date of its annual calculation of its performance incentive as well as its report on expenditure of funds. The request states that delays of gathering information an extension of 3 business days would allow Eversource to file the information.

The Commission has determined that the request for an extension of time is reasonable and will not unduly delay any proceeding or adversely affect the rights of any party. Accordingly, Eversource has until June 6, 2018 to file the reports.
