On January 13, 2015, the Commission voted pursuant to RSA 541-A to initiate a rulemaking to readopt with amendment Puc 2100, the Affiliate Transactions Rules. A rulemaking notice form was filed with the Office of Legislative Services on February 4, 2015, as required by RSA 541-A:6. The notice was published in the Rulemaking Register on February 12, 2015. The notice scheduled a public hearing on the proposed Readoption with Amendment for March 17, 2015.

The hearing was held as scheduled, and comments were received from several parties involved. The Commission considered the public comments in establishing the text of the Final Proposal.

The Commission adopted the Final Proposal in a duly noticed public meeting on May 22, 2015. As required by the Rulemaking Manual, you will find enclosed one copy each of the following:
