Dear Director Howland:

Enclosed please find Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource)'s reconciliation of Stranded Cost Recovery Charge (SCRC) and Energy Service (ES) revenues and expenses for the period April 1, 2015 through June 30, 2015. In the Stipulation and Settlement filed in Docket No. DE 02-127, Eversource, the Office of Consumer Advocate (OCA) and Staff agreed that Eversource would make preliminary quarterly filings reconciling SCRC and ES revenues and expenses.

The preliminary results for the second quarter of 2015 indicate the following:

- (1) The SCRC expenses have exceeded SCRC revenues resulting in an under recovery of approximately \$4.1 million, as shown on page 1 of the attached filing.
- (2) The ES revenues exceeded ES expenses (including Merrimack Scrubber) resulting in an over recovery of approximately \$3.7 million, as shown on page 5 of the attached filing.
