Staff filed a proposed revised procedural schedule on October 9, 2015, in response to Commission orders made during the October 8, 2015, hearing. No party objected to any of the dates and deadlines except for Attorney Cunningham's conflict with the proposed hearing dates during the week of December 7, 2015. The Commission has determined that the proposed schedule below, which does not include hearing dates, is in the public interest and therefore has approved it.

November 19, 9:00 a.m.	Settlement Conference; and
November 30	Environmental assessments due.

The Commission further requests that the parties jointly develop and submit alternative hearing dates in January 2016 for its consideration.
