**Petition for Intervention**

Petitioners, state Senator Jeb Bradley and state Senator Dan Feltes, petition to intervene in the above proceedings, pursuant to Puc 203.02, Puc 203.17 and RSA 541-A:32, and in support state as follows:

1.) Petitioners, Senators Bradley and Feltes, represent District 3 and District 15 in the New Hampshire Senate, respectively.

2.) Petitioner Senator Bradley serves as Majority Leader of the New Hampshire Senate, Chairs the Senate Energy and Natural Resources committee, and was the sponsor of Senate Bill 221. Petitioner Senator Feltes serves on the Senate Energy and Natural Resources committee. Petitioners worked together on Senate Bill 221.

3.) Petitioners also worked together as members of the so-called "State Team", which negotiated with PSNH. Petitioners are signatories to the "2015 Public Service Company of New Hampshire Restructuring and Rate Stabilization Agreement", filed with this Commission on June 10, 2015.

4.) Petitioners' constituents include thousands of PSNH residential and business electric ratepayers. Moreover, as members of the Senate Energy and Natural Resources committee, Petitioners have a substantial interest in state energy policy.

5.) The rights, duties, privileges and other substantial interests of the Petitioners and their constituents may be affected by the above proceedings.

6.) Petitioners seek the status of full party intervenors in the above proceedings.

7.) The granting of this petition will not impair the prompt and orderly conduct of the above proceedings, will not result in delay, and will not prejudice the interest of any party.

8.) The public interest will be promoted by allowing for the intervention of Petitioners.

WHEREFORE, Petitioners, Senator Bradley and Senator Feltes, respectfully request that the Commission:

A. Grant their petition for intervention in the above dockets, and

B. Grant such other relief as is just.


