**AUTHORIZATION FOR CLASS I- THERMAL RENEWABLE  
ENERGY CERTIFICATE (REC) ELIGIBILITY**

The Commission received and staff reviewed the WES Energy & Environment, LLC (WESEE) request for the Commission to modify the Class I Thermal eligibility certificate for the **Mascoma Valley Regional High School** biomass facility from 0.24 megawatt (MW) to 0.3 MW. The Froling P4 Model 80/100 biomass boilers installed at the facility can be configured either for 80 kW or for 100 kW output. WESEE had originally listed the three biomass boilers as 80 kW units and the facility was certified for 0.24 MW. On March 10, 2016, the Commission received a letter from WESEE confirming that the three boilers at the facility actually were installed with a capacity of 100 kW rather than 80 kW, and requesting that the facility therefore be certified for its total actual capacity of 0.3 MW, effective as of February 27, 2015. **Based on Staff's recommendation, the Commission has approved the revision of the REC eligibility certificate for the Mascoma Valley Regional High School biomass facility as a 0.3 MW equivalent facility, with retroactive eligibility for Class I Thermal RECs effective as of February 27, 2015.**
