Petition on behalf of Cianbro Energy, LLC for a Declaratory Ruling regarding Rule Puc 2002.05

### ORDER OF NOTICE

On October 30, 2014, Freedom Logistics, LLC d/b/a Freedom Energy Logistics (FEL), filed a petition for declaratory ruling pursuant to N.H. Code Admin. Rules Puc 207.01, on behalf of its client Cianbro Energy, LLC (Cianbro Energy), regarding the application of Puc 2002.05 to Cianbro Energy and its parent company, The Cianbro Company (Cianbro Company). FEL seeks a ruling from the Commission declaring that Cianbro Energy was not required at any time to have been registered with the Commission as a competitive electric power supplier during the period when it provided electricity to Cianbro Company in New Hampshire.

In its petition, FEL asserts that Cianbro Energy provides electricity to its parent, Cianbro Company, in a number of New England states. Both Cianbro Energy and Cianbro Company are members of the New England Power Pool (NEPOOL) and ISO New England (ISO-NE), Cianbro Energy as a Market Participant End User and Cianbro Company as a Governance-Only member of the End User Sector. As a Market Participant End User, Cianbro Energy is not a member of the Supplier Sector at NEPOOL. The petition asserts that Cianbro Energy ceased supplying electricity to Cianbro Company in New Hampshire in June 2014,but Commission Staff has advised FEL it "continue[s] to believe that Cianbro Energy should have been registered as a competitive electric power supplier with the NHPUC."

According to FEL, Cianbro Company, like any other end-use customer, is entitled to purchase electricity directly from ISO-NE without relying on an intermediary such as Cianbro Energy, and the use of an intermediary is merely an "intra-corporate accounting mechanism so that the books of Cianbro Corporation are handled in the same manner as other states where Cianbro Energy needs and does have a retail license." FEL concludes that, as a Market Participant End User, Cianbro Energy has not been required at any time to be registered as a competitive electric power supplier with the Commission.

FEL's petition and subsequent docket filings, other than any information for which confidential treatment is requested of or granted by the Commission, will be posted to the Commission's website at <a href="http://www.puc.nh.gov/Regulatory/Docketbk/2014/14-305.html">http://www.puc.nh.gov/Regulatory/Docketbk/2014/14-305.html</a>.

FEL's filing raises, <u>inter alia</u>, issues related to the interpretation of RSA 374-F:2 and 7 and RSA 362-F:2, 3, 8 and 10, and N.H. Code Admin. Rules Puc 2002.05 and Puc 2503.03(a) and (c), and their application to Cianbro Energy as a provider of electricity to its parent company.

### Based upon the foregoing, it is hereby

**ORDERED**, that a prehearing conference, pursuant to N.H. Code Admin. Rules Puc 203.15, be held before the Commission located at 21 S. Fruit St., Suite 10, Concord, New Hampshire on December 2, 2014 at 1:00 p.m., at which each party will provide a preliminary statement of its position with regard to the petition and any of the issues set forth in N.H. Code Admin. Rules Puc 203.15; and it is

**FURTHER ORDERED**, that, immediately following the prehearing conference, FEL, the Staff of the Commission, and any intervenors hold a technical session to review the petition and allow FEL to provide any amendments or updates to its filing; and it is
