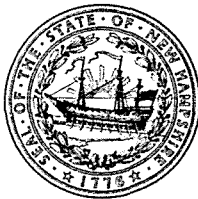

Dear Mr. McNeil:

On November 5, 2014, the Commission received applications filed by the New Hampshire Electric Cooperative (NHEC) requesting Class II eligibility for NHEC member photovoltaic (PV) arrays<sup>1</sup> and inclusion in the NHEC aggregation. The applicants include Hieko Pohl (Pohl), Headley S. White, Jr. (White), Francis Thurber (Thurber), Margaret Turner (Turner), Circle Program (Circle Program), Rebecca Lee (Rebecca Lee) and Robert Lee (Robert Lee).

On November 19, 2014, the Commission received additional applications filed by NHEC requesting Class II eligibility for NHEC member PV arrays and inclusion in the NHEC aggregation. These applicants include Gordon L. Hunt (Hunt), Tim Gotwols (Gotwols), Jeffrey T. Lathrop (Lathrop), Elaine Stockbridge (Stockbridge), Karl Furstenberg (Furstenberg), Don Latulippe (Latulippe), David J. Ludwick, (Ludwick), and Brian Flynn (Flynn).

Staff has reviewed these applications and has recommended approval of these PV arrays as eligible for Class II RECs and inclusion in the NHEC aggregation as listed in the following table:

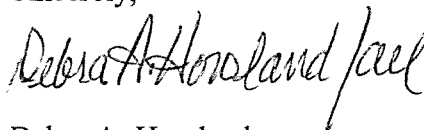
<sup>1</sup> Pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law Class II eligibility requires a facility to produce electricity from solar technologies that began operation after January 1, 2006 (RSA 362-F:4, II).

These facilities are customer-sited sources. Their output is reported as part of the NHEC aggregation to the New England Power Pool Generation Information System (NEPOOL-GIS) as NON32900. In addition to reporting each source's output to the Commission, NHEC will include the total output of these facilities when it reports the total output of all of its Class II eligible facilities, under the name *NHEC Class II Aggregation*, to the NEPOOL-GIS. NHEC also serves as the Independent Monitor for these sources.

The Commission has determined that NHEC has provided all the information necessary to demonstrate these facilities' eligibility for certification and hereby certifies the above named PV arrays as eligible for Class II RECs and inclusion in the NHEC aggregation effective as of the dates listed in the table above.

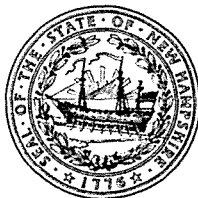

Please be advised that, pursuant to RSA 362-F, the New Hampshire Public Utilities Commission has certified the Hieko Pohl (Pohl), Headley S. White, Jr., (White), Francis Thurber (Thurber), Margaret Turner (Turner), Circle Program (Circle Program), Rebecca Lee (Rebecca Lee) and Robert Lee (Robert Lee) solar photovoltaic (PV) facilities as part of the New Hampshire Electric Cooperative (NHEC) Class II aggregation effective as of November 5, 2014.

In addition, the Commission has certified the Gordon L. Hunt (Hunt), Tim Gotwols (Gotwols), Jeffrey T. Lathrop (Lathrop), Elaine Stockbridge (Stockbridge), Karl Furstenberg (Furstenberg), Don Latulippe (Latulippe), David J. Ludwick, (Ludwick), and Brian Flynn (Flynn) solar photovoltaic (PV) facilities as part of the New Hampshire Electric Cooperative (NHEC) Class II aggregation effective as of November 19, 2014.

Accordingly, NHEC is eligible to be issued Class II RECs for these arrays as of the dates listed in the summary on the following page. The GIS facility code for all NHEC facilities is NON 32900.
