Denial of Application to Renew Registration

Dear Mr. Ginn:

On December 1, 2014, Union Atlantic Electricity Corp. (Union) submitted an application to the Commission to renew its registration as a competitive electric power supplier (CEPS). On December 2, 2014, Staff sent Union a deficiency letter which described items missing from its application.

On January 7, 2015, Staff filed a memorandum recommending that the Commission deny Union's renewal application. According to Staff, Union's registration as a CEPS, approved under Docket No. DM 13-246, and the surety bond included with its initial application, expired as of December 16, 2014. Pursuant to Puc 2003.02, Union's renewal application was due 60 days prior to the termination of its most recently active registration, on October 16, 2014. In its memo, Staff indicated that there were a number of follow-up communications between Staff and Union regarding the submission of missing items required to complete Union's application. However, according to Staff, despite these communications Union has not provided these missing items.

The Commission has reviewed and accepted Staff's recommendation. Accordingly, the Commission has denied Union's application to renew its registration. If Union intends to again register as a CEPS it may apply to do so by filing a new initial application.
