Dear Ms. Howland:

On February 4, 2015 the Commission issued Order 25,760 in this docket, approving Abenaki's request to transition to monthly customer billing. In that order, Abenaki was instructed to publish the order by February 13, and to file an affidavit of publication with the commission no later than March 3. Staff writes to notify the Commission that Abenaki filed its affidavit of publication a day late, on March 4. Through this letter, Staff also cautions Abenaki that utilities are required to abide by Commission orders and can be penalized for failing to do so. *See* RSA 365:41 (authorizing Commission to impose financial penalty on utility for failure to obey Commission order) and RSA 365:42 (authorizing Commission to impose financial penalty on officer or agent of public utility for failure to obey Commission order).

Because publication was accomplished according to the order, the delay was minor, and Abenaki's late filing is not a part of a pattern of practice, Staff does not recommend the Commission take any action on Abenaki's failure to meet the affidavit-filing deadline. Also, this result is consistent with a recent Commission decision in another water proceeding, DW 14-285 Lakes Region Water Company, Secretarial Letter to Parties Extending Deadline (February 23, 2015).
