At the recent Technical Session on October 10, 2019, attended by utility and non-utility representatives, Commission Staff members, and members of the Office of Consumer Advocate, (collectively the Stakeholders) the Stakeholders agreed that Staff would circulate a draft memorandum summarizing progress made at the two technical sessions to the Stakeholders on October 16, 2019. Stakeholders would then provide comments on Staff's draft by October 30, 2019, and Staff would file the final memo, with comments attached, with the Commission on October 31, 2019.
