Electric Delivery Service Tariff No. 9
Approving Tariff

To the Parties:

On March 24, 2016, Eversource Energy (Eversource) filed a request to replace Electric Delivery Service Tariff No. 8 (Tariff 8), with Electric Delivery Service Tariff No. 9 (Tariff 9). Tariff 9 revises the company's name to Eversource Energy. There were no changes to the rates, terms or conditions. It was noted, however, that there are three services in Tariff 8 that are not included in Tariff 9: 1) Sawmill Retention Delivery Service Rate SR, 2) Ski Area Interruptible Delivery Service Rate SKI, and 3) Supplement No. 1 – Temporary Selection Charge, Billing and Payment Service Charge and Collection Services Charge for Energy Service Providers. Eversource does not have any customers subscribed to those three services.

On April 15, 2016, Staff filed a recommendation that the Commission allow Tariff No. 9 to take effect on May 1, 2016.

The Commission has accepted Staff's recommendation that the proposed tariff changes be allowed to take effect as filed. Accordingly, Tariff No. 9 is effective on May 1, 2016.
