<u>Section #</u>	<u>Change</u>	<u>Reason</u>	
2	New Addition	Definitions	Includes definitions of several basic terms used throughout the tariff.
3	New Addition	General Section	This section describes the characteristics of delivery service.
4	New Addition	Availability	Specifies that the Company will arrange for Energy Service for a customer who is not receiving Supplier Service.
5	New Addition	Application, Contract and Commencement of Service	Application, Contract and Commencement of Service were not included in Tariff #19.
7	New Addition	Failure of Payment Agent to Remit Payment	Specifies that the Customer is responsible for amounts due if payment agent fails to remit payment.
8	New Addition	Refusal to Serve	Specifies conditions under which the Company may refuse to provide service.
9	New Addition	Service Connection Charge - Field Visit Required	In the DE 13-063 Settlement Agreement, GSE agreed to review this charge and found it was not included in its tariff.
10	Updated Language	Determination of Demand	Specifies how demand is determined.
19	Title Change	Revenue Guarantee	Changes the title of this section to clarify intent.
20	New Addition	Meters	Describes meter ownership, cost of non-standard meters, failure of a meter to register.
22	New Addition	Customer's Use of Electricity	States that the Company is not responsible for loss, cost, damage, etc. to property resulting from customer wiring, etc. This section also explains customer responsibility to damage to the Company's apparatus or facilities.
24	New Addition	Compliance	Specifies conditions to which the customer must adhere regarding access to premises and use of service.
25	New Addition	Resale of Electricity	Includes language that excludes electric vehicle charging stations from resale prohibition.
26	New Addition	Company Property	Explains the Company's rights to install and maintain its property, along with what the customer must provide without expense to the Company to allow for delivery service.
31	New Addition	Holidays	Defines holidays that are considered as off-peak periods.

32	New Addition	Conjunctural Service	Explains that the customer must comply with the Company's Specifications for Electrical Service if they are to have other sources of electrical service connected on the customer's side of the meter.
33	New Addition	Customer Choice of Rate	Specifies that the customer maintains responsibility for choice of rate.
34	New Addition	Statement by Agent	Limits authority of Company's agents regarding modifying rules of rate provisions.
35	New Addition	Third Party Claims and Non-Negligent Performance	Third Party Claims and Non-Negligent Performance added.
36	Updated Language	Charges for Temporary Services	Temporary services has been updated to define a temporary service and what the Company will charge when one is requested.
37	Updated Language	Stranded Cost Adjustment Factor	Stranded Cost Adjustment Factor has been updated to include background of the charge.
38	Updated Language	Reliability Enhancement Program and Vegetation Management Plan Adjustment	Updated language to include Settlement Agreement in Docket DE 13-063.
39	Updated Language	Reliability Enhancement Program Capital Investment Allowance	Updated language to include Settlement Agreement in Docket DE 13-063.
42	Updated Language	System Benefits Charge	The updated language provides clarification that all customers taking delivery service must pay this charge.
43	Updated Language	Late Payment Charge	The updated language provides clarification as to the customers to whom the late payment charge is not applicable.
48	New Addition	Energy Service	Provides information about Energy Service, along with the rates for each rate class.
62	New Addition	Terms and Conditions for Competitive Suppliers	Terms and Conditions for Competitive Suppliers added. This section describes applicability, definitions, obligations, initiation of service, termination of service, metering, billing and payment
62	New Addition	Business Initiation Fee	This fee is under the Terms and Conditions for Competitive Suppliers. This fee is charged to the Company by the EDI provider and the Company is not able to pass the fee on to the Supplier without Commission approval.

Rate D	Removal of Language	Approved Types of Water Heaters for Use Under Rate D	As this rate provision is closed to new customers as of 1991, this information is no longer needed in the tariff.
Rate D	Addition of Language	6-Hour and 16-Hour Controlled Water Heating	Added clarifying information that the rates are closed to new customers.
Rate D & T	Addition of Language	Interruptible Credits	Added language to close the availability of this provision to new applications.
All Rate Classes	Removal of Language	Transmission, Stranded Cost, Energy Service, Storm Recovery, EAP and SBC	This information is provided in the terms and conditions, and thus is not needed in each rate class schedule.
Rates G-1 & G-2	Removal of Language	Increased Night Use	The Company is requesting to remove this provision in its tariff and has explained why in the Tebbetts Tariff testimony.
Rates G-1 & G-2	Updated Language	Optional Determination of Demand	The Company is requesting a change to this provision and has explained why in the Tebbetts Tariff testimony.
Rate M	Updated Tables	All Light Installations	Clarifies monthly kilowatt-hour usage and includes table for LED lighting.
