Petition for Step Adjustment – Record Request

Dear Attorney Sheehan:

At the May 17, 2018 hearing, the Commission made a record request of Liberty and reserved Exhibit Number 26 for the Company's response. Liberty filed its response to that record request on May 24, 2018. The Commission has determined in order to fully consider Liberty's requested rate adjustment, and before it can issue an order, that additional information concerning the individual capital projects constructed is needed. The Commission therefore makes the following record request and reserves Exhibit Number 27 for Liberty's response. The questions are directed to Anthony Strabone, Project Manager for the Pelham Station Project.

- 1-1. Provide the construction completion date and in-service dates for the following components. In addition, please provide the capital investment associated with each component.
 - i) Substation Rebuild 8830-18000058 Substation equipment.
 - ii) 14L4 Feeder Getaway Installation.
 - iii) 14L4 manhole and duct system located outside the Substation, and
 - iv) The remote monitoring and control portion of the substation rebuild (i.e. RTU equipment, PLC's) (SCADA programming and connectivity, testing, etc.).
- 1-2. Please verify that none of the capital investment proposed for recovery in this docket is associated with the 14L5 feeder.

Liberty is directed to file its response as soon as possible.
