Filing of Rate Schedules

Dear Director Howland:

Pursuant to N.H. Admin. Rules Puc 1600 *et seq.*, Unitil Energy Systems, Inc. (“Unitil Energy”) hereby submits to the New Hampshire Public Utilities Commission (“the Commission”) an original and six (6) copies of its filing in support of its request for a rate increase.

Since its last base rate case filed in 2010, the growth of Unitil Energy’s operating expenses and rate base have significantly exceeded growth in its sales and revenues. Despite its efforts to mitigate these cost increases, Unitil Energy has continued to experience earnings attrition and now requires rate adjustments to balance its revenues with its increased expenses and rate base.

This filing addresses the issue of earnings attrition and includes step adjustments within a 5-year Rate Plan relating to future rate base additions and programs to enhance service reliability and vegetation management. The change in permanent rates proposed for effect with service rendered on and after June 1, 2016 would increase Unitil Energy’s total annual revenues by \$6.26 million, which represents an increase of 3.6 percent above present rates.<sup>1</sup> Unitil Energy is also requesting implementation of temporary rates for service rendered on and after July 1, 2016, and until a final order on permanent rates is issued. The requested temporary rates will produce an increase in annual revenues of \$3.01 million, or a 1.8 percent increase above present rates.

In addition to this cover letter, the enclosed filing consists of originals and six (6) copies of 2 volumes of tariffs, prefiled testimony and supporting schedules, and 1

separate volume of rate case materials as required by Puc 1604.01(a). Volume 1 of the filing includes: this cover letter; the Petition of Unitil Energy; revised NHPUC No. 3 tariff pages; a report on the proposed rate changes; a statement to be provided to customers; an attestation by an officer of Unitil Energy; and certain prefiled testimony and schedules. Volume 2 also contains the testimony and schedules of Unitil Energy's witnesses in support of the filing. The information required by Puc 1604.01(a) is included in the Volume entitled "Supplementary Filing Requirements."

An enclosed disc containing the filing in electronic format is submitted in accordance with Puc 203.03.

Unitil Energy respectfully requests that the Commission issue an order of notice and schedule a prehearing conference.
