RE: DT 16-534: Request for Adoption of Interconnection Agreement

Dear Bob:

On April 28, 2016, the Commission received a "Request for Adoption Under Section 252(i) of the Telecommunications Act of 1996" of the agreement between Northern New England Telephone Operations LLC (FairPoint) and TDS Metrocom, LLC (TDS-M). The cover letter and attached agreement between FairPoint and TDS-M refer to an existing interconnection agreement between YMAX Communications Corp. (YMAX) and FairPoint and describes that existing agreement as "approved by the New Hampshire Public Utilities Commission in Docket 1010-091." FairPoint's filing includes a copy of an interconnection agreement with YMAX that has a handwritten label of "NH-1010-091."

1010-091 is not a Commission docket number.

It appears that this filing may refer to the agreement between Verizon New England Inc. and YMAX filed on June 15, 2006 and approved by Secretarial Letter dated June 27, 2006. That agreement has a title page with a footer of "Ymax NH Comp v2.8c.doc" (matching your filing). The docket number for that agreement is 06-089.

Please make a corrected filing, referring either to the Commission's docket DT 06-089, or to the correct docket if you determine that the agreement being used is from a different source.
