On September 12, 2016, the Commission held a duly noticed prehearing conference in the above referenced matter. Appearances were entered by Public Service Company of New Hampshire d/b/a Eversource Energy, the Office of Consumer Advocate, and Commission Staff.

The Commission's attorney, David K. Wiesner, Esq., presided as the Hearings Examiner and, on September 12, 2016, filed a report summarizing his recommendations. No petitions to intervene were filed.
