Extending Deadline for Initial Filings in Proceeding

To the Parties:

On September 27, 2016, representatives of the parties and Commission Staff (Staff) met in a technical session and agreed to extend the deadline for initial filings in this proceeding from Friday, October 21, 2016, until Monday, October 24, 2016, in order to alleviate a potential scheduling conflict with a stakeholder session in the grid modernization docket, IR 15-296, as reported by Staff in a letter dated September 28, 2016.

The Commission has determined that the proposed initial filing deadline extension is in the public interest and therefore has approved the extension. Accordingly, the deadline for initial filings in this proceeding is October 24, 2016. The procedural schedule otherwise remains in effect.
