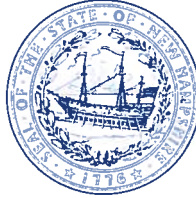

To the Parties:

On July 27, 2018, Commission Staff (Staff) filed a letter requesting that the Commission extend by three months the deadline under Order No. 26,124 (April 30, 2018) for filing a final report containing the proposed scope and timeline for a distribution-level locational distributed generation valuation study, from July 30, 2018 until October 30, 2018.

The Commission has determined that granting an extension will not unduly delay the proceeding or adversely affect the rights of any party. Accordingly, the request to extend the filing deadline for the proposed locational value study scope report to October 30, 2018, has been approved.
