RE: DT 16-595: Request for Adoption of Interconnection Agreement

Dear Mr. Phillips:

On May 24th, 2016, TDS Telecommunications Corporation (TDS) filed an Interconnection Agreement pursuant to 47 U.S.C. §252(e) with SegTEL Inc. d/b/a FirstLight Fiber (FirstLight). FirstLight elected to adopt the terms of the Interconnection Agreement between TDS and Comcast Phone of New Hampshire, LLC d/b/a Comcast Digital Phone pursuant to 47 U.S.C. §252(i).

The Commission elects to take no action on this petition. Accordingly, pursuant to 47 U.S.C. §252(e)(4), the adoption of the Interconnection Agreement will take effect by operation of law 90 days after its filing, on August 22, 2016. Notwithstanding the foregoing, any clause in the Agreement found to be in violation of any Commission order is null and void.

The Commission has updated its records to include the adoption of this agreement. Please refer to Docket No. 16-595 in any future correspondence.
